Independent Contractor Statement and Insurance Release:

* By filling out my name below, I acknowledge, as the artist, that I am responsible for my allotted space as well as supplying myself with anything I may need in my said space at IndieFest 8, including but not limited to chairs, a canopy or umbrella, easels, tables etc. I give my word that I, the artist, will actively promote the event by posting the event flyer and info about IndieFest using social media websites, e-newsletters, my website, etc.

I consent to participation in SDIF come rain or shine, and acknowledge that I fully understand my participation may involve risk of serious injury or death, including losses which may result not only from my own actions, inactions or negligence, but also from the actions, inactions, or negligence of others, the condition of the facilities, equipment, or areas where the event or SDIF is being conducted, and/or the rules for this type of event. I understand that if I have any risk concerns, I should discuss the risks associated with my participation with SDIF coordinators and event staff, before I sign this document and before SDIF begins.

Independent Contractor Statement and Insurance Release:

I certify that I am in good health and have no physical condition that would prevent participation in SDIF.

I agree that photographs, pictures, slides, movies, video, or other media coverage of me may be taken in connection with my participation in SDIF without compensation from the organizers of the 2013 San Diego IndieFest and employees and agents of all of them and consent to the use of photographs, pictures, slides, movies, videos, or other media coverage for any legal or marketing purpose.

Knowing and understanding the risks involved with participation in SDIF, I hereby voluntarily and willingly assume responsibility for all risks and dangers associated with my participation in SDIF. I agree I am financially responsible for any losses resulting from my actions and will indemnify the organizers of the 2013 San Diego IndieFest and employees and agents of all of them, for any loss or damage caused by myself during SDIF.

In consideration of my participation in SDIF, I hereby waive all claims or causes of action against the organizers of the 2013 San Diego IndieFest, employees and agents of all of them, arising out of my participation in SDIF and hereby release, hold harmless, and discharge the organizers of the 2013 San Diego IndieFest, employees and agents of each of them from all liability in connection therewith except such loss or damage which was caused by the sole negligence or willful misconduct of the organizers of the 2013 San Diego IndieFest, employees and agents of all of them.

I have read this release and hold harmless agreement and understand the terms used in it and their legal significance.
